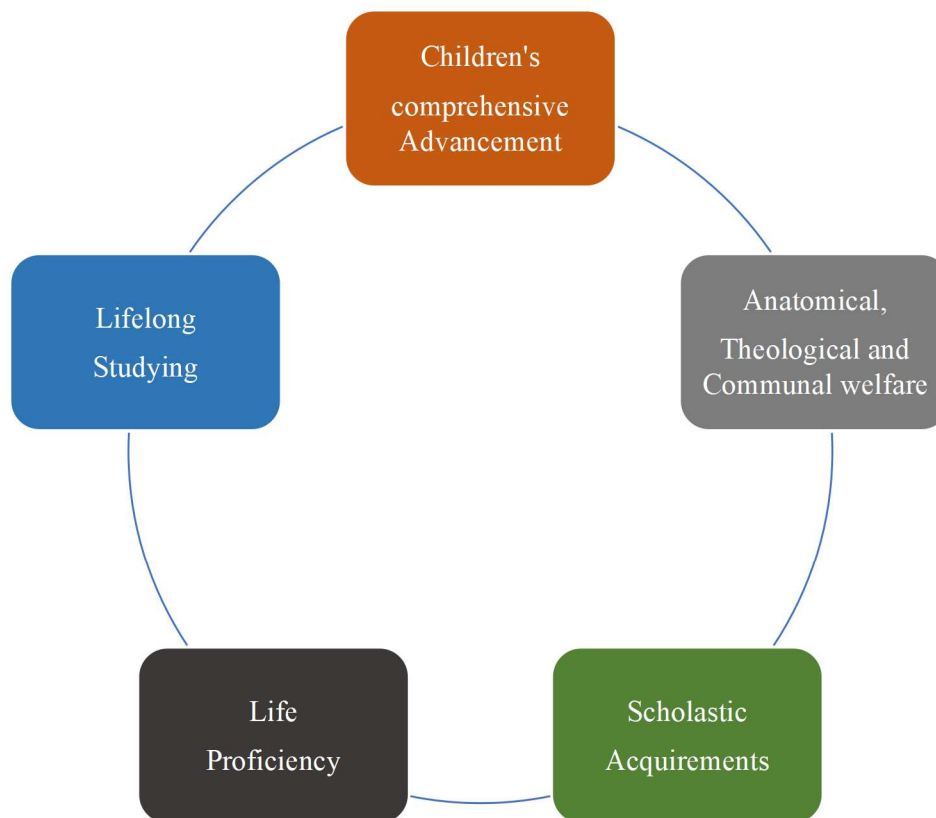


Figure 1 : Children’s advancement and its effect [14]

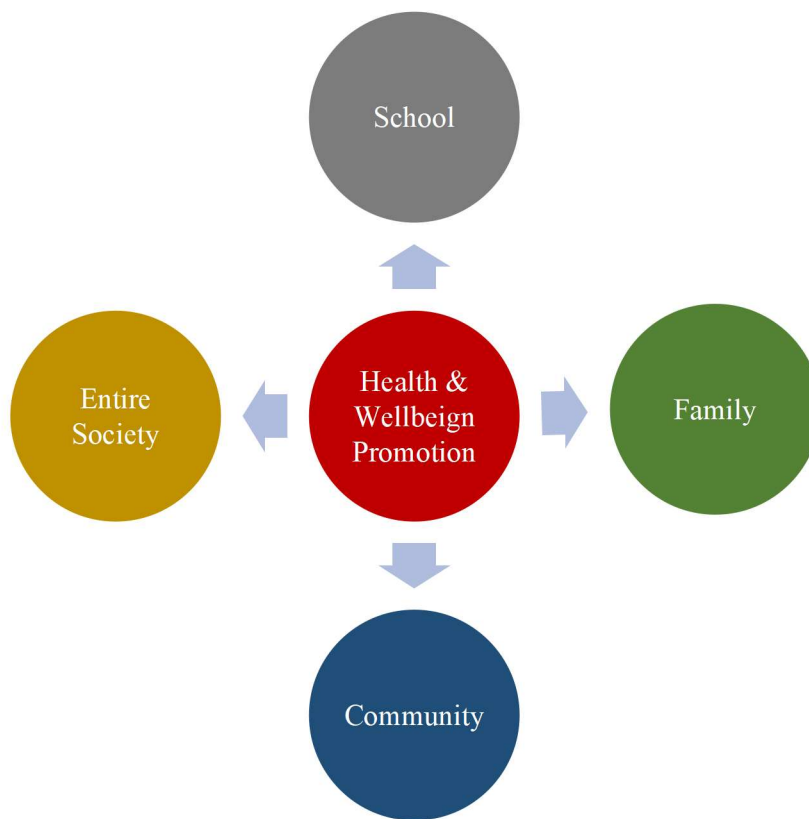


Figure 3 : Relationship among health with community, society& life
